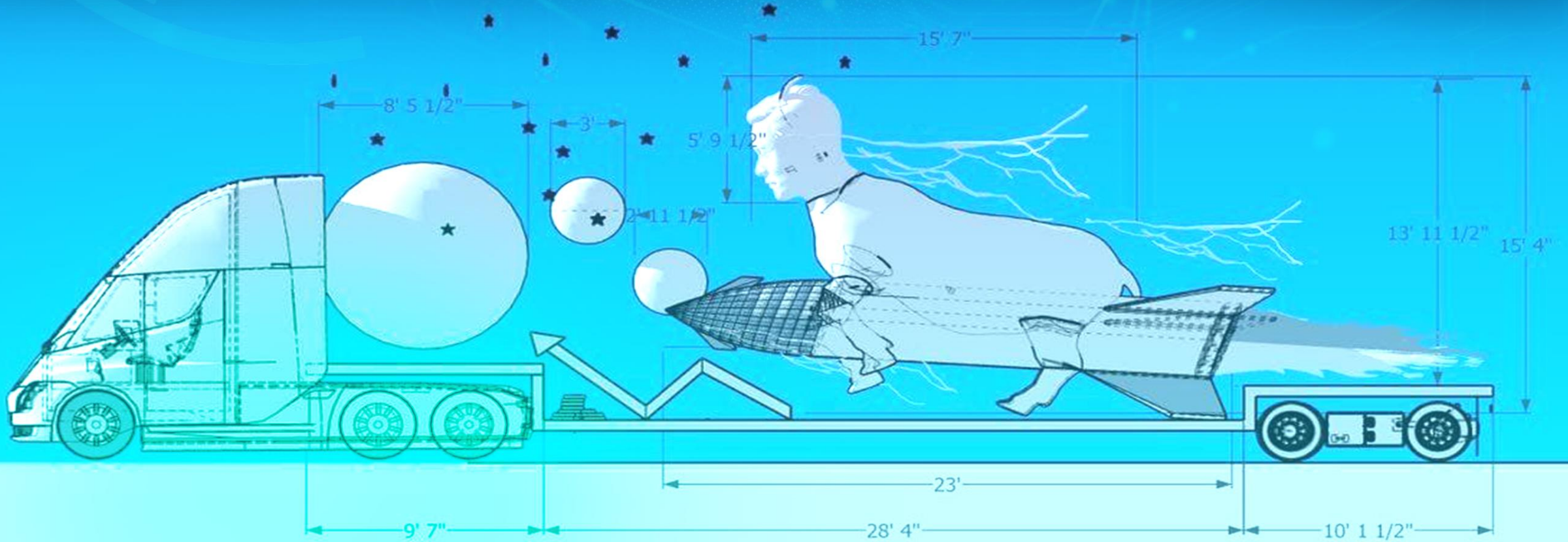
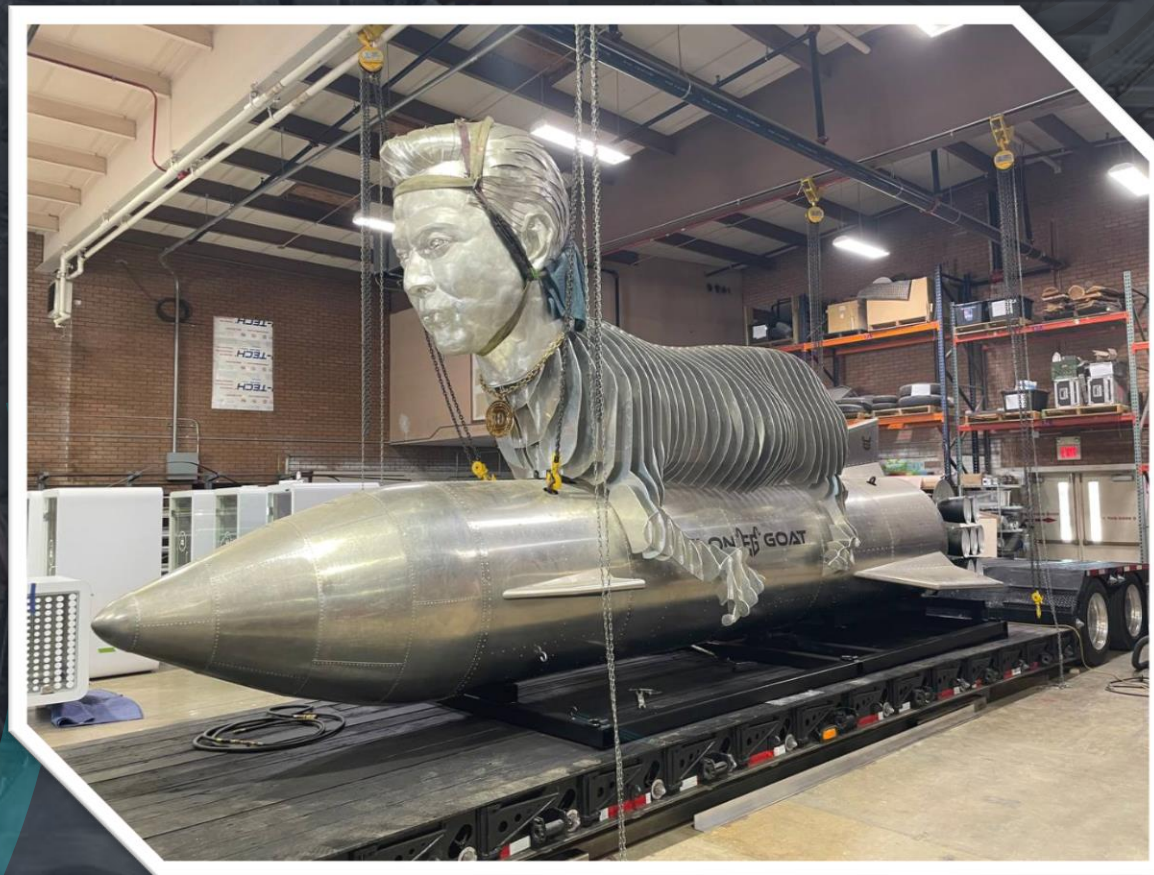

On launch day, \$EGT caught immediate global attention, drawing over 1750 Telegram users on a live call that helped catapult the native Token to a \$39 million dollar market cap. \$EGT's viral and unique marketing plan that focused on getting Elon Musk's attention was the central catalyst.

\$EGT has captured an incredible amount of earned media on platforms such as Fox Business News, CBS and Vice.com. The Token has survived a global cryptocurrency market meltdown and now finds itself well positioned to outperform the market in the next leg of the cryptocurrency adoption cycle.

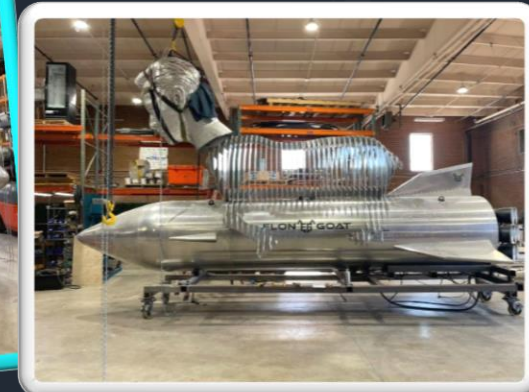

The biblical-sized **Elon GOAT Monument** was engineered to be roadworthy and is now fastened to a 50-foot semi-trailer. The conceptual design was drawn and rendered by Los Angeles-based Danny Wang Design. The six-foot head of the Elon GOAT monument was sculpted in Canada by Elon-recognized, metal animation artist, Kevin Stone. The Rocket and GOAT Body was fabricated in Phoenix, Arizona by acclaimed Burning Man fabricators Spectacle Works.

Elon has been photographed interacting with Spectacle's Burning Man contribution "The Mona Lisa". Elon also used one of Kevin's steel sculptures as his Twitter profile picture in 2019. \$EGT's development team aimed to build a crypto monument that rivalled the "Wall Street Bull" and we feel the mission has been achieved.

Join \$EGT on this viral movement, aimed to generate global anticipation and spark debate. The million-dollar question is; will Elon recognize and claim his monument when it's delivered to his office? Cryptocurrency history will be written and \$EGT plans to play a strategic role in those books.
